Following regulatory approval, Chr. Augustinus Fabrikker has completed the acquisition of Louis Poulsen and is now the sole owner of one of Denmark's most iconic design brands. The investment is in line with Chr. Augustinus Fabrikker's strategy of taking significant ownership positions in established Danish companies with international potential.

Copenhagen, 16 September 2026 - Danish heritage lighting brand Louis Poulsen today confirms that the acquisition by Chr. Augustinus Fabrikker has received the required approval from the competition authorities and has now been completed. The new ownership marks a return to Danish ownership and supports Louis Poulsen's long-term international development.

Since 1874, Louis Poulsen has built a design tradition centred on shaping light. Rooted in Danish design heritage and through collaborations with iconic designers such as Poul Henningsen, Arne Jacobsen, Verner Panton, Finn Juhl, and more, Louis Poulsen stands as The First House of Light with a strong presence globally.

With the transaction now completed, Chr. Augustinus Fabrikker and Louis Poulsen will focus on how the new ownership can best support the company's continued development. The intention is not to change what already works, but to give Louis Poulsen the conditions to grow further internationally.

Chr. Augustinus Fabrikker is a trust ownership with a history dating back to 1750. Their investments are spread across a range of Danish companies and investment positionings, focusing on creating long-term growth to benefit not just returns but also to preserve and develop these for the benefit of society.
